ORDER

Shri. Suman Jacob George, Assistant Professor (Forest Management and Utilisation), College of Forestry, Vellanikkara was granted LWA for 3 years from 01.02.1998 to 31.01.2001 to undergo Ph.D programme in the University of Western Australia. The LWA sanctioned was extended upto 31.01.2003 in different spells.

After the expiry of LWA on 31.01.2003 Shri. Suman Jacob George has neither reported for duty nor communicated any reason for the non-joining. His absence from. 01.02.2003 has been treated as absence which amounts of violation of the provisions in Kerala Service rules and Kerala Servants Conduct Rules. And initiated disciplinary action against him and issued memo of charges of even number dated 26.04.2008 with statement of allegation.

Memo of charges with statement of allegation was served on him in his permanent address and address abroad. He did not reply to this memo. As such detailed enquiry was ordered as per order 2nd read. The officer of enquiry has recommended for taking disciplinary action.

The whole matter was placed before the Executive Committee and the Executive Committee in its 466th meeting held on 04.02.2010 has decided to terminate his service in KAU which shall not be a disqualification for future employment. Show cause notice to this effect has been issued to Shri. Suman

Jacob George as per reference 4th read. Abstract of the same have been published in two dailies dated 07.11.2010 and the whole copy in our website. He has not responded to the show cause notice.

In these circumstances the following orders are issued.

Shri. Suman Jacob George, Assistant Professor, College of Forestry, Vellanikakra is removed from the service of Kerala Agricultural University which shall not be a disqualification for future employment as per Section (vii) of SRO 293/72
